The NCGA Senior 4 Ball Qualifier took place on June 10th. Qualifiers in that one were Bill Bowen and Dennis Snyder along with Tom Horan and Ed Lazarek both teams went to Sectional Qualifying on August 20th. I am very happy to report that Bill Bowen and Denis Snyder shot a net 61 at Bidwell Park Golf Club to qualify for the 15th Annual NCGA Senior Four Ball Championship to be held September 22 & 23 at Poppy Ridge.

Our four-man team of Bill Bowen, Jess Linville, Walter Burks and Denis Niemeyer won the qualifying tournament and advanced to the 2014 Zone Championship at Poppy Hills. They shot a 12 under par in the two-day competition 12 under par was in 25th place. The winners Tulare shot 38 under for a two best balls in the two-day competition.

The Sun City Cup was held Friday, August 22 and was won by Timber Creek (average of 71.37) over Lincoln Hills (average of 75.63). The battle between Sun City Lincoln Hills and Sun City Roseville will continue in 2015 at Lincoln Hills. A great golf round was recorded by Frank Burkhead, he shot a gross score of 69. Congratulations Frank.

The North/South Tournament was a two-man best ball competition with plenty of low scores and plenty of prizes. The North defeated the South by a musket ball for the second year in a row. 
