1. MEETING CALLED TO ORDER Rodger called meeting to order at 3:03 pm

- 2. APPROVE MINUTES Bob July Minutes were approved by all members present.
- 3. <u>FINANCIAL REPORT</u> Phil was absent but submitted the June and July financials. The July ending balance was \$ 22,327.00. The June and July financials were approved by all members present. Ending balances are typically higher in the beginning of the year due to the influx of dues and decline during the year as expenses are incurred.
- 4. <u>MEMBERSHIP REPORT</u> Roger Cummings was absent but submitted his report. We have 234 returning members and 33 new members for a total of 267
- 5. <u>TOURNAMENT REPORT</u> Gene said that there was a large turnout of 136 players for the 4 man scramble in August and we will probably have a similar format yet this year.
- 6. <u>COMMUNICATIONS REPORT</u> Doug Have articles to Doug by September 10
- 7. SUNSHINE REPORT Bob Sent "get well" cards to Brian Wanzer and John Garfein.
- 8. <u>WEBSITE REPORT</u> Al was absent but submitted his report. Posted revised rule on abnormal ground conditions, August Linksletter and August Tournament results for 4 man scramble. Also resolved problem with website email names working.

- 9. <u>SOCIAL REPORT</u> George All food and beverages are set up for the Memorial Tournament.
- 10. <u>SPONSOR REPORT</u> Tom coordinated the design and procurement of two 4ft x 8ft display banners for the Memorial Tournament with our two main sponsors displayed.

Tom asked all Board Members who are hosting one of our sponsors for the Memorial Tournament to contact them directly to fill in the sign up form for golf and/or dinner.

Tom was commended for the excellent job he has done as Director of Sponsors.

- 11. <u>RULES REPORT</u> Roger Val confirmed that the training session for the new golf rules will be held on Wednesday, December 12 from 9:00 am until 3:00 pm. More details about class size and cost will be announced as soon as they are available.
- 12. <u>CVS REPORT</u> Steve reported that CVS has 42 members with one more event on September 10 at Cameron Park. Lincoln Hills hosted the event on August 20 with 19 volunteers and will host next year on September 23. CVS ended the year with a \$686.51 surplus which will probably affect next year's dues. Steve & Jesse will modify the sign up form for next year.
- 13. <u>HANDICAP REPORT</u> Brian reported that out of 265 members, 102 have improved their handicaps so far this year. Brian also noted that a number of members are not posting their scores, so he will address this in an article for the Linksletter.
