

# Emergency Board Meeting Minutes - April 11, 2022 (ZOOM Meeting)

#### 1. MEETING CALLED TO ORDER: Jack

- President Jack Dillon called the meeting to order at 6:02 pm with a quorum present.

## 2. TOURNAMENT REPORT: Jim McGeough

- Jim reported that the April 19 Tournament will go on as scheduled. There are about 150 registrations to date. Registration closes tonight. Jim will be asking for help the day of the tournament with signs, CTP, Long Drive stakes, and tape measures. All were open to help
- We discussed the need for a Tournament Director. It would be very difficult to hold a classy and effective Memorial Tournament when we don't have a TD and the event is only 7 weeks away. Because of this predicament, the Board decided to cancel the June 6 and 7 Memorial Tournament and move the May 17 tournament to Tuesday June 7. We will use this scheduling change to reinforce to the membership how badly we need a TD to make the tournament run well.
- The discussion of selecting tee-prizes has been tabled since there will be no Memorial Tournament in 2022.
- A committee will be formed early 2022 to determine scope and cost of a top-notch Memorial Tournament in 2023. Most of the Board members expressed interest in joining this committee.
