1. MEETING CALLED TO ORDER: Tom

- President Tom Horan called the meeting to order at 3:00pm with a quorum present.

2. APPROVE Previous Meeting Board MINUTES Jim

- Submitted via email, the June 2023 Minutes were approved by the Board. Final version will be posted on our website this week.

3. FINANCIAL REPORT Bruce

- Bruce emailed the June 2023 report. The following was presented at the meeting.
 - o MGCLH; \$25,744 Hole-in-One; \$1,064 CVS; \$5,998.
- June 2023 Financial report was approved by the Board.
- Bruce reported that Jeff Warner will be trained to become the Treasurer for 2024.....and beyond.
- The Board approved the Club payment of the NCGA Senior Qualifier. These should be put into future budgets.

4. TOURNAMENT REPORT: Mike/Keith/Jim

- Keith advised that we have 4 players (two 2-some teams) that have qualified to move on to the NCGA Senior Qualifier. They will be playing at Ancil Hoffman in August and the winners will be invited to the finals at Poppy Hills later in the year. The cost is \$300/team. Jim moved that the Men's Club should pay for the two registrations (\$600) since these two teams will be representing the MGCLH. The Board approved the expense. Keith will get these gentlemen

- registered.
- Chad and Keith have been discussing 2024 tournament dates. Based on individual tournament participation, Chad would like us to consider utilizing only one course. There were several reasons why we need to utilize both courses, not the least being pace-of-play. We will counter this by advising Chad that we can give him a 7-day "guarantee" of our required tee-times and then he can release the remaining tee-times to the general public.
- August Tournament: As we know, we have one Tournament Director (Keith) and 2 back-ups (Mike and Jim). Unfortunately, for the August Tournament, the Tournament Director and one back-up will be out of the state for an extended period and will not be able to participate in the preliminary prep or day-of implementation. The remaining back-up may also be unavailable. The tournament date is August 15. The Club will make a final determination on the status of the tournament by August 8. The tournament could be cancelled, altered, changed format, or go as planned.

5. MEMBERSHIP REPORT: Bob

- Bob advised that we started 2023 with 290 renewing members and have enrolled 36 new members. Total is 326 year-to-date.
- Jim presented the 2024 NCGA fee structure. There will be a \$7 increase for new members and renewing members. There are several questions on how the MGCLH will handle this increase and how it will affect our tiered pricing, and renewal dates. A sub-committee was established (Bruce, Jim, Bob, and Jeff) to discuss how MGCLH will handle renewals and tiered pricing for the remainder of 2023 and into 2024.
